Transition to Organic Partnership Program (TOPP)

- USDA's \$100 million investment over five years with non-profit organizations to provide technical assistance and support to producers seeking or maintaining organic certification.
- **Goal** → remove technical, cultural and financial barriers to certification, making it accessible to producers of all sizes and backgrounds.
- Builds \rightarrow
 - Farmer to Farmer mentorships,
 - Technical Assistance and Educational Resources,
 - Strengthens regional partnerships between farmers and service providers,
 - Creates a stronger network of organic producers

Transition to Organic Partnership Program Mid-Atlantic/NE Region



Mentorship

Connect transitioning producers with experienced organic mentors.



Deliver 1:1 technical assistance to help producers and handlers navigate organic certification at their own pace.

Events

Organize events for producers, handlers and agricultural professionals.

Certification

Support operations — from urban farms to large scale farms—successfully achieve organic certification.

Understanding Organic Poultry Processing

- USDA Organic certification applies to the entire production system—from feed and animal welfare to land management and recordkeeping.
- Poultry must be raised according to organic standards before arriving at the processor.
- Certification is not retroactive—processing organic birds at an organic facility does not automatically make your product certified.
- The **processor (like Steadfast)** must also be certified, but they can only process and label your birds as organic *if you are certified too*.

Certification includes:

- Organic feed and pasture access
- No antibiotics or synthetic additives
- Detailed records and inspection

- Organic Processing: No additional cost per bird for organic processing.
- One-time Organic Paperwork Fee: \$500 per farm covers all label submissions and USDA compliance.*
 (Farms may also complete <u>USDA compliance verification</u> independently with no charge)
 (*changes to label, process that require new submissions would require a new fee)
- **Discounted Tier Pricing:** Tier Level 2 pricing (3,501 5,500 birds annually) applied collectively across all NOFA member farms, certified organic and conventional.
 - Lowered cost entry barriers for smaller producers
 - Improved mortality terms and priority scheduling
 - Prorated deposits Seasonal Volume Program Deposit- based on individual farm volume
